Act of Appeals, 1533, 24 Hen. The term 'empire' had a much different connotation in the early sixteenth century than it has today. The British Empire of the twentieth century means the extensive territories of which the King of England is titular head. But in 1533 'empire' meant simply 'a country of which the sovereign owes no allegiance to any foreign superior', i.e., pope or emperor. See Baumer, p 29
